**Terms and Conditions**

1. **Collections will be performed Mondays, Wednesdays and Fridays, excluding holidays. Black Pond Veterinary Service requires notification of a collection no later than 4PM EST the day before shipment is required** (i.e. 2 days before it is needed). Requests are to be made by **phone only to 1-781-659-7798**. Services are available from March 15 until August 15 unless individual arrangements are agreed upon in advance between owner and Black Pond Veterinary Service. Off day collections or same day shipments may be available on a limited basis for an **additional fee of \$100**.
2. Owners are to provide Black Pond Veterinary Service with an active credit card number so that collection and shipping fees may be billed directly to the owner. **Each collection is billed at \$250**. Owner understands that if stallion is collected once and shipment is split, there will only be one collection fee billed. However, should two collections be needed to meet required shipments, then a second collection fee will be billed. If a trial collection is desired (recommended for stallions who have not been collected by us before, or there has been significant time since last collection) it will be billed at \$150.
3. Shipping fees via FedEx are variable and will be charged on an individual basis. Should owner provide their own FedEx account number for shipping purposes, Black Pond Veterinary Service will charge an additional \$20 handling fee. It is either the mare or stallion owner’s responsibility to make sure that Black Pond Veterinary Service is provided with the correct address for FedEx to ship to. Owner understands that no shipment will be sent if payment is not received prior to shipment. Black Pond Veterinary Service is not responsible for lost, delayed or damaged semen.
4. Owner understands that not all stallions are candidates for shipped semen. Black Pond Veterinary Service cannot guarantee the quality or fertility of semen collected and processed here, nor can we guarantee a collection can be obtained as requested. It is understood that an individual stallions availability may vary due to illness, show schedules, unforeseen circumstances.

5. Owner shall assume all responsibility for the condition of the horse and shall bear all risk of loss or damage to the horse whatsoever by death, disease, injury, infection, or otherwise, and by any cause whatsoever, unless such damage or loss to or by the horse is caused by gross negligence or willful misconduct of Black Pond Veterinary Service and/or Whit Acres Farm, their employees, and agents. Otherwise, the owner releases, discharges, indemnifies, and holds harmless these same parties from any liability for any and all damages associated therewith. The owner hereby agrees to pay all expenses and attorney's fees incurred by Black Pond Veterinary Service and/or Whit Acres Farm in defending any claims for which the horse owner has agreed to release, discharge, indemnify and hold harmless.
6. Stallion must be free of any infection or contagious disease or sickness. A current coggins test is required with this contract. The stallion owner must provide proof that stallion has received all required annual vaccinations as instructed by licensed veterinarian prior to having any collections processed.
7. Black Pond Veterinary Service reserves the right to make arrangements should emergency or additional medical care be necessary in the event of sickness, disease, or injury. Any and all expenses incurred will be the sole responsibility of the owner.
8. Black Pond Veterinary Service reserves the right to decline to provide services to the stallion for any and all reasons. We also reserve the right to use whatever means of restraint necessary for the safety of the stallion and/or the handler under any circumstances. Owner understands that the handling and collection process is inherently dangerous and we do not allow owner participation at any time.
9. This contract contains the entire understanding of the parties and may be modified only in writing signed by all parties. The invalidity or unenforceability of any term or provision of this contract shall not affect the validity or enforceability of any remaining provisions hereunder. This contract shall be construed and governed by the laws of Massachusetts, and the parties expressly agree the jurisdiction and venue for any and all disputes arising under this contract shall be proper only in Plymouth County, Massachusetts. In the event that Black Pond Veterinary Service and/or Whit Acres Farm incurs attorney fees and/or legal costs in securing or protecting any right available to it under this contract or under the laws of Massachusetts, the horse owner agrees to pay said attorney fees and costs.
10. Black Pond Veterinary Service reserves the right to amend this contract at any time.
